Copyright is a type of intellectual property that gives its owner the exclusive right to make copies of a creative work, usually for a limited time. The creative work may be in a literary, artistic, educational, or musical form. Copyright is intended to protect the original expression of an idea in the form of a creative work, but not the idea itself. A copyright is subject to limitations based on public interest considerations, such as the fair use doctrine in the United States. Copyrights can be granted by public law and are in that case considered "territorial rights". This means that copyrights granted by the law of a certain state, do not extend beyond the territory of that specific jurisdiction. Copyrights of this type vary by country; many countries, and sometimes a large group of countries, have made agreements with other countries on procedures applicable when works "cross" national borders or national rights are inconsistent. In this talk students gained the knowledge about process of obtaining copy rights for the products formulated in various industries across the globe. Followed by scientific sessions a Q and A session was conducted. Over 126 participants attended the seminar and Convener and Principal, Prof. K. A one day Webinar on IPR & Regulatory Guidelines in Various Countries was organized by Institution Innovation Council (IIC) of Vijaya Institute of Pharmaceutical Sciences for Women on 17-07-2021. Dr. V. Sai Kishore, Head of Pharmaceutics Dept. Bapatla College of Pharmacy, Mr. S. V. Suresh Babu, Deputy Manager, Regulatory Affairs Eywa Pharma Pvt Ltd, Chennai and Mr. I.V. Post inauguration Dr. V. Sai Kishore delivered a talk on Regulatory Considerations in New Drug Development Process. Further, special emphasis was given on various regulatory aspects involved in developing a new drug or new drug product, different stages of pre-clinical and clinical trials and marketing strategies of the new drug product. By the end of session delegates gained knowledge about the challenges that are faced by pharmaceutical industries in developing a new drug or a new drug product and different applications that are required to be filed in various countries to introduce the drug or drug product in the market.

The second talk was given by Mr. S. V. Suresh Babu on Generic Drug Product Development, Regulatory Registration and Post Approval Changes. In this talk special emphasis was given on developing, registering and the changes that have to be made after approval. Generic drugs are medicinal products that can be manufactured and marketed by others than the innovator company after the original patents have expired. Different countries established different procedures in approving this generic drug products and the main aim of establishing this policies are to increase the global access to and regulation of generic drugs, reduce drug costs, and prevent drug shortages and supply disruption. Particularly, the availability of low-priced generic drugs is important to increase the economical access to drug treatment in low- and middle-income countries. By the end of talk delegates had got an access

The third talk was given by Mr. I.V. Suman Kumar on Regulatory Pathway for Generic Drugs in Japan. Where, in this talk special emphasis on different regulatory guidelines followed by Japan to market the generic drugs. Generic drugs are interchangeable with original proprietary drugs, as they have the same active pharmaceutical ingredients, dosage forms, strength, quality, indications, effects, directions, and dosage. The cost of generic drugs is lower than original drugs, because the developmental cost is lower. The expansion of medical expenses is an important issue in many countries, including Japan, the USA, and Europe, and promotion of generic drugs has been demanded to solve this issue in Japan. Generic drug approval review in Japan is conducted by the Pharmaceuticals and Medical Devices Agency (PMDA), which reviews the equivalence of the original drugs from the viewpoint of quality, efficacy, and safety, based on documentation submitted by the generic drug applicants. From the session delegates gained knowledge about the different procedures that have to be followed to market a generic drug product in Japan.

Vote of thanks was given by Dr. Sivadasu Praveen. 250 participants attended the webinar, and it was conducted through the online platforms of zoom and you tube.








Professor, Dr. NRS Govt. Ayurvedic College, Vijayawada, Dr. Krishna Undela, Asst. Professor, Dept. of Pharmacy Practice, NIPER-G, Assam and Dr. N. Srinivas, Statistician, Planning Dept. Andhra Pradesh Capital Region Development Authority (AP- CRDA, Govt. of Andhra Pradesh were invited as Guest Speakers. Prof. Dr. K. Padmalatha, Principal was the convener of the webinar; Dr. S. Venkateswara Rao and Dr. Sivadasu Praveen were the coordinators of the webinar.

Post inauguration on the first day Dr. T.E. Gopala Krishna Murthy delivered a talk on Opportunities and Constraints of Academic Research, where special emphasis was given on various opportunities and constraints in the academic research. By the end of the talk

students understood about the opportunities and the various problems faced by the researchers in the academic point of view.

The second talk was given by **Dr. C V S Subrahmanyam** on **Interpretation of Results in Research.** In this talk special emphasis was given on how to interpretate the results obtained in research in a detailed manner. Generally, people often simply summarize their results because they do not know how to interpret their findings. Interpretation of results is considered as an important step in the research process. Interpreting is about seeing whether the result confirms or does not confirm with the findings of previous studies in the literature review. The findings may also offer novel insights or information. By the end of the session students gained insights about interpreting the results obtained in a research work.

The last talk of the first day was given by **Dr B. Prasanna** on **Recent Advances in Ayurveda Research.** She spoke about the recent advancements that are happening in the field of Ayurveda. It is a science of life with a holistic approach to health and personalized medicine. It is one of the oldest medical systems, which comprises of thousands of medical concepts and hypotheses. Interestingly, Ayurveda has the ability to treat many chronic diseases such as cancer, diabetes, arthritis, and asthma, which are untreatable in modern medicine. Unfortunately, due to lack of scientific validation of various concepts, this precious gift is trailing. Hence, evidence-based research is highly needed for global recognition and acceptance which further needs advancements in research methodology. By the end of the session students gained knowledge about the recent developments in the field of Ayurveda.

On the second day **Dr. Krishna Undela's** talk on **Research Process: Identification** and **Designing a Research Project** gave importance to enlighten the students about how to identify a research work and design a research project. The function of a research design is to ensure that the evidence obtained enables to address the research problem as unambiguously as possible. In social sciences research, obtaining evidence relevant to the research problem generally entails specifying the type of evidence needed to test a theory, to evaluate a program, or to accurately describe a phenomenon. However, researchers can often begin their investigations far too early, before they have thought critically about what information is required to answer the study's research questions. Without attending to these design issues

first, the conclusions drawn being weak and unconvincing and, consequently, will fail to adequately address the overall research problem. By the end of the session students gained knowledge about how to identify a research problem and design a research project.

On the second day the final talk was given by Dr. N. Srinivas on Statistics in Research-Data Analytics-Statistical Computing. Various statistical tools that are used in the data analysis were explained evidently. It's the science of collecting, exploring and presenting large amounts of data to discover the underlying patterns and trends. Statistics are applied every day - in research, industry and government - to become more scientific about decisions that need to be made. By the end of the session, students understood about various tools that are used in analysing the data with live examples.

Vote of thanks was given by Dr. Sivadasu Praveen. 356 participants attended the webinar, and it was conducted through the online platforms of zoom and you tube.







