Teachers' feedback is collected individually.

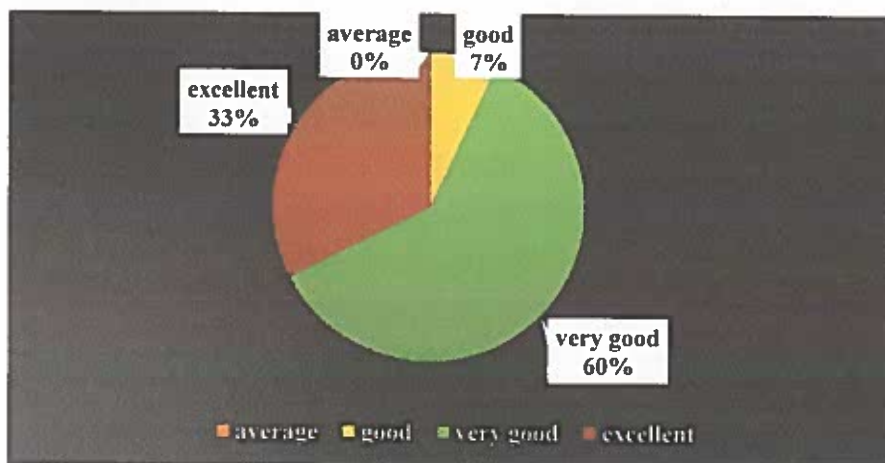

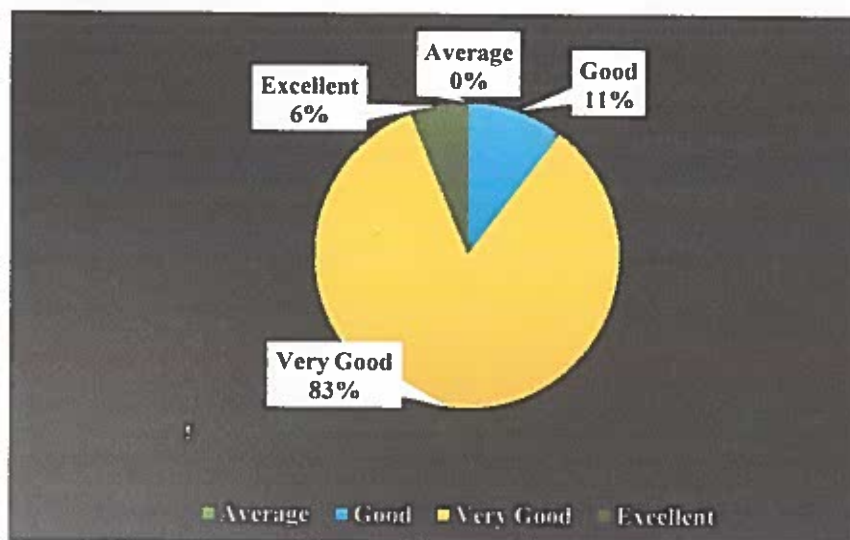
1. Course content present in the syllabus
