



Chronic Kidney Disease (CKD) is a condition in which deterioration of kidney function occurs gradually over time. Hypertension (HTN) and Diabetes type II (DM II) were the major causes of CKD in most of the cases. Medication Therapy Problems (MTPs) were constantly observed in patients affected by CKD. Therefore, additional care should be provided to these patients. As part of this special care management, the profound activities of the clinical pharmacist were considerable. Clinical pharmacists play a pivotal role in correcting these medication therapy issues and inappropriate prescription patterns. The main objective of the study was to provide information related to the effectiveness of clinical pharmacist activities in the management of MTPs in CKD patients. The acceptance rate of these pharmacist-based interventions by physicians ranged from 79 to about 95%. Most of the literature reviewed demonstrates the positive impact associated with clinical pharmacist activities. Further increased research should be performed to increase the quantitative assessment of clinical pharmacist services.

ABSTRACT: The Medication Therapy Problem (MTP) Categories Framework is a consensus-based document developed by the Pharmacy Quality Alliance's (PQA's) Measure Development Team (MDT) 9, to provide a framework for development of measures involving MTPs. The framework is intended to standardize how MTPs identified during Medication Therapy Management (MTM) encounters are categorized within measures. The MDT incorporated input from numerous MTM providers and practices and referred to MTP categories established in the literature. This standard framework for use within measures will promote consistent categorization and coding of MTPs and the related actions/recommendations to resolve the MTPs. Medication Therapy Management (MTM) can be assessed in multiple ways. Currently, 2 - MTM measures are endorsed by PQA. The Completion Rate for Comprehensive Medication Review measure assesses the extent to which MTM-eligible patients receive a comprehensive medication review during their MTM-eligibility period. The Medication Therapy Problem Resolution (MTPR) monitoring measure is based on the PQA Medication Therapy Problem Categories Framework and evaluates the percentage of interventions that resolve medication therapy problems among individuals participating in an MTM program. PQA also has 2 - quality improvement indicators that focus on MTM i.e., Completion Rate for Comprehensive Medication Review (CMR) and Martication Therapy Problem Resolution (MTPR) monitoring measure.
