1. Discussed in detail the M.Pharmacy Course regulation and syllabus prescribed by Pharmacy Council of India (PCI) for 10 specializations and resolved to implement the same in JNTUK and its affiliated colleges w.e.f from 2018-19 academic year. These regulations will be called as MPH R18 Regulations.

3. The following minor changes are made in the syllabus and are approved
- In the course content of M.Pharm Pharmaceutics, Course No. MPH204T in Cosmetics and Cosmeceuticals is replaced with the course title Formulation Development of Pharmaceutical and Cosmetic Products. The syllabi of this course is as given in the Appendix-I
  - For all 10 specializations, the Practical-I that is prescribed in First Semester is divided into two practicals, Practical-I and Practical – II, each for 75 marks carrying 3 Credit points. Similarly, Practical – II in the Second Semester is divided into two practicals, Practical – III and Practical – IV, each for 75 marks carrying 3 Credit points.
  - The divisions of prescribed experiments in Practicals into Practical I, II, III & IV are shown in the syllabus of corresponding specializations.
