

Vijaya Institute of Pharmaceutical Sciences for Women conducted a program on "Curbing the Menace of Ragging" and its preventive measures on 17.09.2016. Mr. B. Sambasiva Rao addressed the students regarding the consequences of ragging. He said that ragging is defined ragging as display of noisy, disorderly conduct, doing an act which is likely to cause physical or physiological harm or raise apprehension, fear, shame or embrassement to a student. And also deliberated ragging is a punishable crime with imprisonment for a term which may extend to two years and shall be liable to a fine which may extend to Rs. 10,000 under section 4 of the Act.

He also addressed students should not belie the expectations of their parents by indulging in the illegal act of ragging and mentioned that the AICTE Act provided a ban on students who indulged in ragging from appearing for the university exams.

Finally, he brought out the significance of the practice which originated as an act aimed at forging friendly relationship between seniors and juniors. But, unfortunately, it had taken ugly overtones over the years necessitating an Act to prohibit ragging.

About 387 students from I, II, III & IV B. Pharm and I & II Pharm D attended the program. Dr. K. Padmalatha, Principal of VIPW expressed thanks to the speaker of the day.
