

- (c) The research scholar must undergo course work during the 1<sup>st</sup> year as provided in the Ph.D. Regulations. The Research Advisory Committee shall prescribe the course work and methodology of research and conduct the Research Methodology Examination and perform such other functions as required under the Ph.D. Regulations. Completion of the prescribed course work is a precondition to appear for the Research Methodology Examination at the end of 1<sup>st</sup> year after provisional registration. The Research Methodology Examination will be conducted in the Deemed University premises only. Every research scholar shall be examined by the Research Advisory Committee by written and oral tests to assess his/her skills.
- (d) Relevant documentary evidence of having completed the course work including certificates duly certified by the Research Advisory Committee, should be submitted by the research scholar to the Controller of Examinations before taking Part – I Research Methodology Examination. Otherwise, the research scholar will not be permitted to take the said Examination.
