





The program was conducted by Dr. Y. Ashok Kumar & team, Ramesh Hospitals, Vijayawada. The teaching and non-teaching staff members along with Principal, dr. K. Padmalatha participated in the event. CPR is an emergency procedure that combines chest compression followed by exhaling air in to the patient's mouth or nose (mouth-mouth resuscitation). The measures are taken to restore blood circulation and breathing in a person who is in cardiac arrest. It is recommended to those who are unresponsive with no breathing or abnormal breathing/inaccurate assessement of presence or absence of pulse. This health care technique restarts heart, brain functioning, and protects from permanent brain damage. The session on first aid education is essential to impart knowledge and skills particularly in rescuing the patients. The faculty members expressed that the emergency rescue technique CPR will certainly help the needy cardiac arrest patients. The management of VIPW, Dr. K. Padmalatha, Principal of VIPW thanked the invitees and participants for making the program successful.
