POLICY for DISABLED (DIVYANGJAN)

Vijaya Institute of Pharmaceutical Sciences for Womenprovideshighereducation for women and an adencourages inclusive participation of all students. In this connection, the institute promotes education and assists differently abled students in creating employment opportunities.

The college has institutionalized the following policies for facilitating the Women Students with Disabilities:

- To provide personal and professional counseling, keeping in view their special needs.
- Toencouragestudentswithdisabilitiesfromruralbackgroundtopursuehighereducation, hostel fee is waived.
- Will not reject any admission on basis of being differently abled.
- Disseminate information regarding government or university orders dealing with fee
 concessions, examination procedures, reservation, policies, etc., pertaining to
 differently abledpersons.
- Assess the educational needs of differently abled persons enrolled in the higher education institutes to determine the types of assistive devices to beprocured.
- Assess the ability of differently abled students and assist them in getting appropriate employment by providing special training facility.

Support System: Support system enables people with disabilities to move about safely and freely, and use the facilities within the built environment. The disabled friendlyequipment is to provide an environment that supports the independent functioning of individuals so that they can participate without assistance, in everyday activities. To the maximum extent possiblebuilding is supported with railings for their accessibility. The ramp shall be wide enough that a wheelchair user can use it without anyproblem. A wheel chair is also provided by the institution.

Disabled friendly Washrooms: Separate washrooms with Western Waters Closet and grab bars are arranged in the ground floor. Toilets shall be wide enough for free movement of differently abled students.

Scribes for Examination: The institution shall provide or allow scribes for those students who are in need while writing exams. Controller of Examinations shall allow the student on the recommendations of Principal to grant extra time to disabled candidates for answering papers at University examinations. Extra time up to 20mins per hour can be given to complete thepaper.

In the case of students who are eligible for availing the services of scribes, the Principal shall authorize to appoint scribes according to the following conditions.

- iii. The educational qualifications of the scribe shall be less than those of the student.
- iv. A pro forma with declaration in the format given institute shall be obtained from the scribe. The pro forma signed by the scribe shall be forwarded to theinstitute.

The institution as per the guidelinesof the government and that of the affiliating university will ensure that the persons with disabilities are encouraged.
