AN OVERVIEW ON SERVICES OF PHARMACY PRACTICE (PHARM. D)

Pharmacy Practice is the discipline within pharmacy that involves developing the professional roles of the pharmacist. The practice of pharmacy is aimed at providing and promoting the best use of drugs and other health care services and products, by patients and members of the public. It requires that the welfare of the patient is the pharmacist's prime concern at all times.

Pharmacy Practice is evolved to enable pharmacy professionals to work towards the new practice standards, to support the reflection on practice and demonstrate the development of patient-centered consultations, using the consultation skills for pharmacy practice learning and development programme.

HISTORY

The development of clinical pharmacy started in USA in the mid 1960's. More clinically oriented curriculum were designed with the award of Pharm. D degree. which influenced the practice of pharmacy in U.K. Initially prescription and drug administration records were introduced followed by increasing pharmacy practice in hospital wards. Master degree programs in clinical pharmacy were introduced for the first time in 1976. The progress of clinical pharmacy development remained at low profile in the first decade after its birth in U.K. However, Nuffield report in 1986 geared up the momentum for profession of clinical pharmacy all over the world. But till today, the clinical pharmacy practice in Nepal is in embryonic stage.
